HISTORY WAS MADE TODAY AS THE U.S. SUPREME COURT RETURNED MARRIAGE EQUALITY TO CA. 6/26 The Court also invalidated the discriminatory Defense of Marriage Act (DOMA) – so *finally* couples in the growing number of marriage equality states will also get the federal rights and benefits they deserve. And though today will be remembered as a watershed moment in the fight for equality, the Court unfortunately stopped short of a broader decision on the fundamental right to marry. Millions of us have been fighting for years – first to stop Prop. 8 from passing, and then to reverse it. Today's victory, while joyous, is a reminder of the long road to win marriage equality nationwide.

RHODE ISLAND JOINS NEW ENGLAND STATES FOR MARRIAGE EQUALITY

Governor Chafee's message says it all. Good for Rhode Island. Now all of New England can show the way to equality. – John & Becky

It's an incredible day in the Ocean State.

May 2, 2013

Moments ago, I signed into law legislation granting marriage equality to all loving, committed couples in our state. And now it's official: Rhode Island is the 10th state to secure the freedom to marry for all families.

Rhode Island is no longer an island of inequality in New England. We affirmed our shared principles of diversity, inclusion, and equality, which have defined what it means to be a Rhode Islander since Roger Williams landed at India Point in 1636. I couldn't be more proud.

When we began this legislative session, I called upon members of the General Assembly to quickly consider and adopt this legislation -- in honor of our forefathers who risked their lives and fortune in the pursuit of our "lively experiment." I'm incredibly grateful to our legislators who, after an open and honest debate, decided our state will prosper when all families are recognized and protected. They stood on the side of love and sent these important bills to me for my signature.

But above all, I'm grateful for you and the tens of thousands of marriage supporters across the state. When some said that it couldn't be done, that marriage equality would never pass in Rhode Island, you didn't back down. You kept pushing forward. You knocked on more than 25,000 doors and worked alongside your neighbors and friends to build a campaign unlike any other our state has ever seen.

Simply put: today would not have been possible without you.

Today, Rhode Island is a better place for all who call this great state home. Years from now, generations of Rhode Islanders will look back to this historic moment -- and I will be forever indebted to you and every single person who helped move us forward.

As the wife of a service member, Casey should be treated the same way other military spouses are treated. As Shannon puts it:

What Casey and Shannon want for their family is simple: to be recognized and treated as equal to every other military family. They want their children to know that their marriage and their family is no different than any other military family.

DELAWARE VOTES FOR SAME-SEX MARRIAGE

May 7, 2013

It's a spectacular day for marriage nationwide, especially for thousands of loving same-sex couples in Delaware. Moments ago, the Delaware Senate voted in favor of the freedom to marry, and the bill is headed straight to Gov. Jack Markell, who has promised to sign it into law.

This win in Delaware builds on the amazing momentum we have experienced this year nationwide. Just last week, Rhode Island became the tenth state to end the restriction on marriage for same-sex couples, and we've already seen the legislatures in Illinois, Minnesota, and Nevada take huge steps forward this year.

Today's victory and all of these other accomplishments would not have been possible without your commitment and support. With your help, Freedom to Marry has deployed key staff and expertise to Delaware, contributing nearly \$200,000 to fund lobbying, media, and a strong grassroots organizing effort in the state.

FROM THE TASK FORCE:

Today [May 29] is an historic moment in Puerto Rico.

Governor Alejandro García Padilla signed into law civil rights legislation that finally provides sweeping nondiscrimination protections for LGBT people and their families and protects same-sex couples under Puerto Rico's domestic violence law.

The Puerto Rican Legislature yesterday finished its legislative process by approving these two bills.

The Task Force has been at the forefront of this struggle, working alongside the Puerto Rican LGBT community for the past seven years, speaking out against hate crimes and anti-LGBT violence. And last year the Task Force's National Religious Leadership Roundtable met in Puerto Rico as a demonstration of the support of the faith community.



The historic news just keeps coming – Minnesota just passed marriage equality, becoming the third state in just 11 days to decide to treat all love equally.

Last fall, we were working to stop a statewide marriage *ban* in Minnesota. Now, six months later, marriage equality is the law of the land in Minnesota.

We set out to win in four states before the Supreme Court ruling, and we're well on our way. There are now 56 *million* people living in states with marriage equality. ... Sincerely,

As you may have heard, the Boy Scouts of America today passed, with a 61%-39% vote, to change their policy regarding openly gay scouts. PFLAG NATIONAL STATEMENT ON THE BOY SCOUTS OF AMERICA NEW SCOUTING POLICY

5/23/13 PFLAG National has issued the following statement regarding today's vote which has officially changed the Boy Scouts of America (BSA) policy and will now allow openly gay youth to become Boy Scouts:

PFLAG National believes that, while the BSA has today taken a step in the right direction, the new policy is still, at its heart, discriminatory against our gay and lesbian loved ones.

Inclusion, by its very nature, cannot be selective: either you are a welcoming organization or you are not. In going halfway with this policy, the BSA suggests that their members are only capable of being trustworthy, loyal, helpful, courteous and kind until their 18th birthdays. Once taught, do these traits diminish or disappear once a child comes of age? Shouldn't being a scout serve as the best training to then lead other scouts in the future? And for same-sex parents who want to participate as leaders in their children's troops, should the message be that their commitment to their child's scouting activities is suspect?

At PFLAG National, we are troubled by the message this sends to ALL youth and adults about what it means to be a truly inclusive organization. We hope that the BSA will quickly realize that the organization is still on the wrong side of history, and take the necessary step to do the right thing by ALL of its members, denying no person membership or a position in the scouts based solely on their sexual orientation.



SOCIAL SECURITY MODERNIZES GENDER MARKER POLICY

SSA has announced the modernization of the medical requirements transgender people must show to update the gender marker on their social security record.

This means that transgender people will no longer have to meet an archaic surgery requirement because the SSA has replaced that requirement with "appropriate clinical treatment" the way several other federal agencies already have done.

As a transgender woman, I can't adequately express to you how exciting this news is for the transgender community. This policy change is potentially the largest federal win our community has ever had!

I work every day with transgender people who are navigating the bureaucracy required to change their documentation and this change will have a tremendous impact on their lives. When trans people apply for jobs, seek health care, housing or travel they often face discrimination when their ID documents don't match up. Because Social Security documents feed into other federal systems, this change will have a tremendous impact and make it easier for their ID documents to match their gender identity. ...

While we're extremely excited by this major victory, we know there's still more work to do and will continue to work with federal agencies to fight for policies that will benefit the entire LGBT community.

This whole thing has been a bit surreal for us because we have been raised to believe that love is love. We never realized that our happiness and openness would inspire so many individuals. The support we have received from our family, friends, and even strangers has led us to believe that our affection for each other is normal ... When we started dating a year [ago], the thought of a photo of us traveling throughout the world would be a bit frightening, but now we are proud to be part of the LGBT community.

Kaeleigh has received many awards and participated in Hall's GSA (2010-2012) and the Action Club (2011-2012). Kaeleigh also participated in several media interviews regarding transgender youth, including **In the Life's** "<u>Becoming Me</u>" and the Rhode Island Monthly Magazine's issue on trans youth. She is our media STAR! Kaeleigh and her family are PFLAG Hartford members.

<u>Casey</u> – Casey is a graduate of East Lyme High School. She will attend The University of New Hampshire this fall with a major in Equine Studies. Casey worked with her GSA and Diversity Club where she led the Day of Silence and also put on an Ally Week to educate the school about LGBTQIA issues and to enlist students to become Allies and stand up to bullying. She was also instrumental in setting up gender-neutral bathrooms to create a safe space for everyone in her school. Casey's awards and accomplishments are too many to list but she has been a very enthusiastic student and community leader.

Shanique – Shanique is a graduate of Classical Magnet School in Hartford. Shanique will attend Lasell College to study for a Bachelors degree in Business Marketing and Fashion Communications. Shanique is a member of Youth Health Service Corps; Safe Space President; A.C.T.I.O.N. Officer. She attended the Uof H Summer Art program and was a facilitator for the Names Can Hurt Us program. She facilitated a workshop at the True Colors Conference about life as a feminine lesbian and the adversities that feminine lesbians face. This well-rounded student also was a member of her school's Indoor Track & Field CSC Champions' team; Volleyball Captain. This very busy young woman has participated in 13 community service projects.

<u>Jose</u> – Jose graduated from New Britain High School and will attend Tunxis Community College this fall and his courses will have an emphasis on Social Work. Jose has successfully juggled his coursework with extracurricular activities and a part-time job. Jose was President of his school's GSA his junior and senior years, and participated in Ally Week, the Day of Silence, and raised money for World AIDS Day. In addition to advocating for LGBT issues, Jose has helped to collect books for children in the pediatric ward of the Hospital of Central Connecticut, and he sold ribbons during Domestic Violence Awareness month for the Prudence Crandall Center.


