GAY MARRIAGE LAW CLEARS LAST HURDLE IN ENGLAND

LONDON – Gay marriage is to become legal in England and Wales after the lower house of the British parliament approved the final changes ... to a law that had Prime Minister David Cameron's backing but split his ruling Conservative Party.

The law had the support of both Labour and the Liberal Democrats, Britain's two other main political parties, but damaged Cameron's standing within his own party with many of his own lawmakers criticizing him for being too liberal. His own members of parliament had previously twice voted against it.

After a two-hour debate, the House of Commons passed the bill, meaning it only needs to be approved by Queen Elizabeth II, a formality.

"The title of the bill might be 'Marriage,' but its fabric is about freedom and respect," said Culture Secretary Maria Miller, adding that traditionalists should not feel their concept of marriage had been undermined: "Freedom to marry regardless of sexuality or gender, but also freedom to believe that marriage should be of one man and one woman, and not be marginalized," she said

The prime minister endorsed the bill to try to show his party was progressive, but that upset some Conservatives who said their Christian beliefs led them to oppose marriage other than between a man and a woman.

Gay couples may already obtain "civil partnerships," conferring the same legal rights as marriage.

NEW ZEALAND: With a vote in April, New Zealand became the 13th country in the world to legalize same-sex marriage. The law took effect in August.



I'm proud to share that the Office of Civil Rights at the Department of Education (DOE) recently announced plans to collect information on LGBT bullying in schools across the country. This is truly a breakthrough worth celebrating because it means LGBT student experiences will now be recorded and analyzed to help drive school policy.

GLSEN has been pushing for the inclusion of this data for some time, and helped lead the conversation that resulted in this action by the DOE.

At the official announcement, a senior official from the Department approached GLSEN Student Ambassador Liam Arne. "I need to shake your hand," he said. "Because of you, the Secretary of Education is adding LGBT students to the most important Department of Education data collection instruments."

This development, championed by our GLSEN Student Ambassadors and other student leadership teams, is critical to informing government and helping our lawmakers take action to ensure that LGBT students have equal access to quality education.

Thanks to [our supporters], we are able to share our story in Washington D.C. and across the nation to bring about real change and develop school climates where difference is valued for the positive contribution it makes in creating a more vibrant and diverse community.

PRESSURE MOUNTS ON IOC AMID BACKLASH ON RUSSIA ANTI-GAY LAW**Next president will inherit controversy after election next month** *By Ian Munroe, CBC News Posted: Aug 12, 2013*

Growing international criticism of a new Russian law against gay "propaganda" has left some observers wondering whether the Sochi Games will leave an indelible mark not only on the host nation but the Olympic movement itself. Rights groups say Russia is in the midst of a period of repression, particularly since the reelection of President Vladimir Putin last year. They point to a raft of repressive new laws, the most recent of which involves a vaguely worded ban on "propaganda for non-traditional sexual relations," under threat of steep fines or jail time.

In recent weeks, the new measure has sparked ever-louder calls to boycott the Olympic Games in Sochi this February, or to relocate them to a country that is more amenable to gay rights. The controversy has even prompted public statements from Western leaders including Prime Minister Stephen Harper and U.S. President Barack Obama.

The contentious Russian legislation poses a problem for the International Olympic Committee (IOC) and not only because of the negative publicity it has been generating. It also appears to contravene the "fundamental principles" of the Olympic Charter, which promotes non-discrimination. Finally, it could potentially threaten the safety of those who will attend the Sochi Games.

At a news conference on Friday, IOC president Jacques Rogge said he had received "written assurances" on the issue from his Russian counterparts. "But there are still uncertainties and we have decided to ask for more clarification," he said. "The Olympic Charter is very clear. It says that sport is a human right and it should be available to all."

Olympic officials are likely working quietly to convince leaders in the Kremlin that they need to do more to guarantee the anti-gay law won't threaten the safety of Olympic athletes, officials or fans, said Dick Pound, a former senior member of the IOC and ex-head of the World Anti-Doping Agency. "The answer is to get it done, and not to stand up on some pulpit and start preaching," he said in a phone interview with CBC News.

Legitimacy at risk?

Others who have been involved with the Games in the past say they would like to see the IOC take a firmer public stance on the matter. "The Olympic movement has got to take the lead in opposing this outrageous law and ensuring in the very least that the Winter Games go ahead with the full recognition of human rights," said Bruce Kidd, a former Olympian and professor at the University of Toronto who has written a book on IOC reform. "That's not happened recently. That didn't happen in China," he added. "At the very least it has to happen in Sochi or the Olympic movement will lose considerable legitimacy among lots of people, including lots of people in sport."

Kidd said he hopes that Russia's anti-gay law becomes an issue next month when the IOC's 104 members converge at the Buenos Aires Hilton hotel to elect a new president. Rogge is due to step down after 12 years at the helm of the international body, paving the way for a new top official. Kidd said he believes the incoming president will determine to a large extent how the IOC will handle the escalating controversy. "This is like a major change in government in what is a one-party state," he said.

Calls for reform

Minky Worden, the director of global initiatives with Human Rights Watch (HRW), said her organization and other like-minded advocacy groups will be lobbying for the IOC to elect a president next month "who's actually going to enforce the human rights requirements of the Olympic charter."

Last week, HRW released a report listing abuses it has documented in Sochi, a city of 300,000 in southern Russia, as preparations for the Games move ahead. The report cites "government efforts to intimidate several organizations and individuals who have investigated or spoken out against abuse of migrant workers, the impact of the construction of Olympic venues and infrastructure on the environment and health of residents, and unfair compensation for people forcibly evicted from their homes," as well as harassment of journalists who are reporting on the preparations.

When Olympic Pride House, a group which had set up a gay-friendly facility at the previous Games in London and Vancouver, applied to do the same in Sochi the report says the application was turned down by a Russian judge who wrote that hosting Olympic Pride House would "contradict the foundations of public morality."

"It's fair to say that Russia is going to give the Beijing Olympics a run for the money on human rights abuses, particularly the crackdown on the LGBT community and civil society," Worden said in a phone interview. "This will be the first homophobic Olympics, certainly. That's without precedent."

WAL-MART SAID IT WILL OFFER HEALTH COVERAGE TO SAME-SEX PARTNERS NEXT YEAR*The Advocate 8/27/13, by Tiffany Hsu*

Wal-Mart Stores Inc., the largest private employer in the country, plans to start offering health coverage next year to domestic partners of full-time employees – including those in same-sex relationships. The extension, outlined in a postcard sent to workers this week, follows a series of recent court rulings in favor of gay marriage around the country.

Though spokesman Randy Hargrove said it's unclear many people may sign up for the program, he said that more than half of the company's 1.3 million U.S. associates are covered by the retailer's health insurance plan. That equates to 1.1 million associates and family members, he said.

To qualify for Wal-Mart's coverage, associates must "live together in an ongoing, exclusive, committed relationship similar to marriage" with a same- or opposite-sex spouse or unmarried partner and "have been together at least 12 months and intend to continue sharing a household indefinitely," Hargrove said.

"Since we operate in all 50 states, we thought it was important to develop a single definition so we can ensure consistency for all our associates across the country," Hargrove said.

The Bentonville, Ark., retail giant also noted that 2014 comes with a new vision plan, including eye exams, glasses and contacts. Wal-Mart also said employees would see the lowest medical premium increases in years – somewhere between 3% and 10% from last year, Hargrove said.

I am currently on my way to D.C. for tomorrow's Let Freedom Ring Commemoration and Call to Action Ceremony. In less than 24 hours - sometime between 12:15 and 12:30 ET - I will stand on the very stage that A. Philip Randolph, Bayard Rustin, John Lewis and Martin Luther King Jr. spoke from on that amazing day 50 years ago. I won't really believe it until I'm standing there.

Today, many have heard of Bayard Rustin, one of the March's primary organizers, and President Obama has awarded him the Presidential Medal of Freedom posthumously. But if you look at the original program of speakers for the March, you won't find his name listed. As a Socialist and an openly gay man, Rustin was not given an opportunity to speak for himself in 1963.

A. Philip Randolph, Rustin's mentor and friend, made sure that Rustin had a moment on stage in the end - but his role was carefully circumscribed: He would read out the demands of the March in a symbolic call-and-response with the crowd.

In assembling their program, The King Center wanted to be sure to include LGBT voices. While GLSEN will be the only LGBT organization represented on the stage, all of the speakers will bring their whole selves to this event, no matter who they are.

I am honored to participate in tomorrow's commemoration, and come to this call to action to pledge GLSEN's full commitment to the fight that must continue. We are in a fight to hold hard-won ground, while still fighting for real equity and equality of opportunity for so many. We need all hands on deck, together, and all voices in the fight to reach a point where freedom truly rings equally for all.

We have such work to do to make sure that the doors of opportunity are open wide for every single child in this country. The barriers to progress are many and varied, and our work will not be done until they all are swept away. Thank you for being part of the fight and for making our work possible.

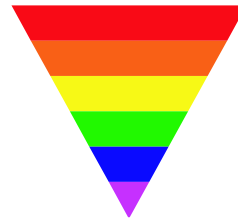
